



By purchasing a ticket for Wetwheels Jersey Summer Raffle 2026, the ticket purchaser agrees to be bound by these terms and conditions.

1. Wetwheels Jersey Limited (**WWJ**) is promoting “Wetwheels Jersey Summer Raffle 2026”. Wetwheels Jersey is a registered charity in Jersey. Jersey Charity Commission number 338.
2. The Raffle is regulated by the Jersey Gambling Commission (JGC) Permit #CR-2571-26 and is required to provide JGC with details of all prize winners.
3. There will be 10 prizes available:
 - **First Prize** - A 25-30 minute helicopter ride around Jersey for you plus a friend
 - **Second Prize** - A plane ride around Jersey for you plus a friend
 - **Third Prize** - A 2 hour trip on Wetwheels for you and up to 9 friends
 - **Fourth Prize** - £250 Cash
 - **Fifth Prize** – Voucher for Dinner for four at the Savoy (drinks not included) To be taken within one month of the draw.
 - **Sixth prize** - £100 cash
 - **Seventh Prize** - Afternoon Tea for 2 people at Longueville Manor
 - **Eighth Prize** - A private tour of Corbiere Lighthouse for 4 people
 - **Ninth Prize** - A £50 South Pier voucher
 - **Tenth Prize** - A £40 Animal Kingdom voucher
1. All those affiliated with WWJ are permitted to purchase tickets except the Promoter
2. Only 3,000 Tickets will be available for the Summer Raffle 2026.
3. Tickets will be sold at £10.00 each, with a maximum of 20 tickets per purchaser.
4. Tickets are only eligible for purchase by adults aged 18 years old or over.
5. All tickets for the Summer raffle 2026 are non-transferable and non-refundable.
6. Ticket sales will close at 12 noon on Friday 28th August 2026, or upon being sold out.

7. Only tickets for which full payment has been received by close of sales will be entered into the raffle and eligible to win one of the ten prizes.
8. No unsold tickets will be entered into the draw.
9. Only one name can be entered as the ticket purchaser. The prize will be awarded to that person in accordance with these terms and conditions.
10. The ticket purchaser is responsible for providing WWJ with accurate and up to date contact details of ticket holder, i.e., full name, telephone number and email, if available. The ticket purchaser shall inform WWJ of any changes to these details as soon as they arise. This information will be stored in line with GDPR.
11. WWJ will be in no way liable for the failure or inability to contact a ticket holder due to any errors, omissions or inaccuracies in the information provided by the ticket purchaser.
12. Age verification for ticket sales will be managed at point of sale, with photographic ID being requested if there is doubt regarding the age of purchaser.

Any ticket purchaser found to be under 18 years of age will be notified and reported to the Jersey Gambling Commission (JGC). The ticket will be refunded and revert to WWJ for resale.
13. **Hard copy** tickets are eligible for purchase by persons in Jersey at the time of purchase with the full understanding that should they win, they will be required to claim the prize in person.
14. Hard copy ticket purchasers will be issued a printed ticket, numbered between 1 and 750.
15. Hard copy ticket sales are deemed final as evidenced by the handover of the ticket.
16. The Summer Raffle 2026 draw will take place on Friday 28 August 2026 at the St Helier Yacht Club at 16:00 subject to the terms of Clause 19.
17. WWJ reserves the right to change the venue of the draw but not the date or time. WWJ shall endeavour to notify all ticket purchasers of any change to the venue through wetwheel.je, social media, local media and the email provided at time of purchase.
18. The Summer Raffle 2026 draw will be made by using an online random number generator. Prizes will be drawn in order from first prize to tenth.



19. All attendees of the draw event will witness the Summer Raffle 2026 draw.
20. The Summer Raffle 2026 draw will be broadcast live on social media.
21. WWJ will publish the sole definitive results of the draw on Wetwheels.je and social media.
22. All prize winners will be notified directly by WWJ.
23. All prizes must be claimed by 29 February 2026. Non-claimed prizes will be forfeit and revert to WWJ.

25. Any decision made in accordance with these terms and conditions shall be final and binding.
